Deliver work on: Saturday, May 6, from 8:30 AM to 9:30AM and/or pick up previous show's artwork at that time. If unable to do so, please ask your alternate contact person to pick it up. The Exhibit Committee will not be responsible for artwork that is not picked up at the designated date and time noted above.

There is NO reception.

RULES:

1. Each artist may enter one piece of approved artwork for judging and one approved BOGO per exhibit.
2. The work must be frame or gallery wrapped, wired, bumpers affixed, clean and in good condition.
3. Work must not exceed 36" in either direction. Size limit is necessary due to restricted space.
4. Work must not be more than five years old.
5. Work must be original. Reproductions of other artists' work, published photos, greeting cards or prints of any kind are not acceptable.
6. No religious, political themes or nudes will be accepted. Work done in a workshop may be eligible for entry only if the subject matter and reference material is that of the artist.
7. Work must remain for the entire length of the show. In the event a painting is sold, the artist should contact the Exhibit Committee Chair to arrange for a similar size replacement to be substituted at the same time as the removal. One exchange -One trip!
8. Specific Artwork must be exhibited only once at each venue.
9. If a theme is announced for a show, an artist's work must reflect the theme to qualify for 1st, 2nd, and 3rd prize.
10. The Exhibit Committee Chair reserves the right to decline an entry into a specific show prior to judging for failure to follow the stated rules and the entry fee will be refunded. If an entry is disqualified after judging, the piece will be removed, the entry fee will not be refunded, and any prize awarded will be rescinded. The Exhibit Chair's decision is final.
